

2011 SUMMER PROGRAM PAYMENT PLAN APPLICATION

Overview

A five-month payment plan option is available to all families. The amount covered by the payment plan is equal to the total tuition and fees less the application fee, tuition deposit and any financial aid awarded. Families who do not apply for financial aid, or apply for but do not receive financial aid, are assessed a service charge of \$50 for using the payment plan. Families who receive financial aid are not assessed a service charge for using the payment plan.

The first payment of the payment plan is due upon the student's acceptance to the program, and subsequent payments are due on the 15th of each month following. Payments may be made by check, money order or credit card. Payments must be up to date on Opening Day in order for students to check in for the program.
