

# SUMMER PROGRAM 2008 PAYMENT PLAN APPLICATION

## Overview

A five month payment plan is available to students in the Apogee, Spectrum, and Equinox programs. **NO PAYMENT PLAN IS AVAILABLE FOR LEAPFROG STUDENTS.** The amount covered by the plan is equal to the tuition and fees less the application fee, tuition deposit, and any financial aid received.

Families choosing the payment plan option who do not apply for financial aid, or apply for, but do not receive financial aid, are assessed a service charge of \$50 for the plan. Families of students receiving financial aid will not be assessed a service charge for using the payment plan.

The first payment is due when the applicant is notified of acceptance to the program. Subsequent payments are due on the 30th of each month following the applicant's acceptance. Payments must be made with check or money order. Credit/Debit cards are not accepted for payment plan installments. If the applicant is accepted into the program, an agreement and monthly coupons will be prepared and sent with the acceptance packet.

## Payments

A five month payment plan is available.

- The first payment of the plan is due when the applicant is notified of acceptance into the summer program.
- Subsequent payments are due on the 30th of each month following the applicant's acceptance.
- Payments must be paid with check or money order.
- Families who apply for and receive financial aid and who choose the payment plan option will **not** be assessed the \$50 service charge.
