- Submit lesson plans to CTD for review and archiving according to program requirements.
- Choose and request appropriate instructional materials for the course.
- Review student medical notes as needed (i.e., allergies/other medical needs).
- Develop an environment that encourages engagement, collaboration, and academic risk-taking.
- Support and supervise teaching assistant's engagement with students.
- Maintain program standard of student supervision.
- Complete student evaluations based on learning objectives and CTD guidelines.
- Learn and implement CTD Policies and Procedures.
- Uphold and promote the CTD Honor Code among staff and students.
- Assume program-related responsibilities (e.g., training) as requested by CTD administrators.
